# Approval of Minutes - November 23, 2015

A motion was made to approve the minutes from November, 2015. Mr. Kaneshiki made a correction to page three stating the concert should be dedicated to Native Americans. Ms. Watson made a correction to the last line on the first page it should read "culture" not "cultural." Ms. Moreno indicated on page two "there" needs to be changed to "their" under re-grant applications. A motion was made to approve the minutes as corrected by Ms. Merighi. The motion was seconded by Mr. Kaneshiki and passed unanimously. Ms. Lods abstained.

# Special Request from the Cumberland County Black Hall of Fame – Barbara Holmes

Ms. Holmes is a board member for the Cumberland County Black Hall of Fame, the Black Hall of Fame is asking for assistance with paying for the rental fee at the Cumberland County College. Commission members received an email in their packet from Ms. Boykin explaining the request. The Black Hall of Fame sponsored its first Teen Talent Showcase in 2015 at the College and the College waived the rental fee, unfortunately the College cannot waive the \$423 rental fee in 2016. The showcase will take place on April 20, 2016 and it is open to the public. The showcase is held to raise funds for eight students to receive scholarships. Ms. Holmes said many different talents are showcased; signing, poetry, piano. Ms. Watson asked who picks the students that participate in the showcase, and Ms. Holmes replied that the high school teachers pick the students. Freeholder Sheppard commented that there is no winner or loser at the showcase. Ms. Holmes said there is not but they are working on ideas for the student that sells the most tickets to receive some type of award/gift. Ms. Boykin said all students receive a certificate of participation. Mr. Pisarski asked about attendance, and Ms. Holmes responded that a couple hundred people attended. Mr. Thakur suggested having the audience pay to vote for viewer's choice award as a way to raise funds. Ms. Silver asked what the monetary value is for the scholarships, there are eight scholarships awarded at \$500 each. Two African American students are chosen from each high school in the county. Mr. Pisarski explained to Ms. Holmes that if the Commission approved funding that it would be a one-time award. Mr. Pisarski

thanked Ms. Holmes for attending the meeting and said he will let her know what the Commission decides. Several Commission members questioned why the college was now charging, and the thought was that enrollment is down and they no longer have the extra funding. A motion was made to approve the rental fee of \$423 by Ms. Lods. The motion was seconded by Ms. Silver and passed unanimously. Ms. Boykin abstained.

Ms. Watson said she read an article that the Noyes Museum is moving, Mr. Pisarski said SJCA is moving into Kramer Hall at Stockton in Hammonton and Noyes will also be in Kramer Hall with SJCA.

#### **Correspondence**

A letter was received from Senate President Sweeney regarding the member representation of the NJ State Council on the Arts and the NJ Historical Commission. Susan Gogan from WheatonArts received a call from the chair of NJ State Council on the Arts stating South Jersey is underrepresented and there are two open seats and they are looking for nominations. The Commission needs to come up with a short list to give to Senator Sweeney's office. A committee needs to be formed so a list can be sent to the Senators office. Ms. Lods, Ms. Merighi, Mr. Kaneshiki and Freeholder Sheppard will be on the committee. Mr. Pisarski will contact Susan Gogan and see if she has any ideas.
